#### ORDER

WHEREAS, in terms of Saction 15(1) of the NCTE Act, 1993, Vagisha Educational Trust. Piot No. 936 to 945, Strept/Road, Raind Road, VIII- Kera, Po-Bhakharuan More, Daudnagar, Piot No. 936 to 945, Strept/City-Daudnagar, Dist. Advangabad, Bihar 924113 has applied for grant of recognition/permission to Bhagwan Frasad Sheonain Frasad B.Ed. College, Piot No. 936 to 945, Street No. Patha Road, VIII- Kera, Po-Bhakharuan More, College, Piot No. 936 to 945, Street No. Patha Road, VIII- Kera, Po-Bhakharuan More, Daudnagar, Tehsil/Tajuka, Daudnagar, Town/City-Daudnagar, Dist.- Aurangabadi Bihar-Batting Cade No.: ERCAPP3475 for additional intake in B.Ed. programme online on 17.06.2015 for two year ducation and hard copy received by Eastern Regional Committee of NCTE on 25.06.2015.

- 2. AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VI and videography, and the certificates received from the affiliating body, the Committee is salisfied that the applicant fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.
- 3. AND WHEREAS, as per the decision of 213th ERC meeting held on 29th -30th April 2016 & 111-2th May, 2016, formal permission order under clause 7(16) was issued vide No. 46318 doted 02.05.2016 with an intake of 50 (one basic unit) from the academic session 2016-2017 to the institution.
- AND WHEREAS, the institution, being aggreved with the decision of ERC, filed Writter Pelition bearing No. W.P.(C) No. 2750 of 2016 before the Hon'ble High Court of Orlssa and the same matter was placed in 225th ERC Meeling held on 16-16 November, 2016. The Committee decided that the prayer of the Pelitioner to accord revised recognition for the required another one unit is not at all possible at present as the cut of date for grant of recognition is over for the session 2016-2017 and in no circumstances, the same can be taken for consideration. As such the application of the petitioner for grant of recognition/permission for another one unit stands disposed of and it is open for the applicant to make afresh application as per NCTE Regulation, 2014 for the next academic session for consideration.
- 5. AND WHEREAS, The Institution has submitted representation dated 25.04.2017 along with D.D. of Rs. 1,50,000/- and a copy of the Order passed in Writ Petition bearing W.P. No. 22417(w) of 2016 by the Hon'ble High Court of Orissa. The Hon'ble High Court disposed of the matter on 17.04.2017 with a direction interalla:

"We dispose of this writ petition with the direction that although the time for filing of the application for the academic session 2017-18 has already expired, but in case

the said application, along with regulate fees and necessary documents, is filed by the petitioner with the opposite party No. 1-NCTE along with certified copy of this order on or before 25.04.2017, the same shall be treated as tresh application filed within time, and shall be decided on its own mett and necessary orders for intake of students in the institution of the petitioner for the academic session 2017-18 shall be passed in accordance with Law."

In view of the above, the Committee decided as under.

In addition to 50 intake already granted from the academic session 2016-2017 earlier, the Committee decided that formal recognition Order under clause 7(16) of the NCTE Regulation, 2014 for applied 5.Ed. programme with another 50 Intake from the session 2017-2018 be issued to the institution, thus making the sum total grant of 200 intake.

- NOW THEREFORE, in exercise of the powers vested under Section 15(3)(a) of the NCTE ACL 1993 Me Eastern Regional Committee. NCTE hereby grants recognition/permission to Bhagwan Pratabilities and Etal College, 1994 to 1994 to 945, Street No. Paina Road, VIII- Kera, Po- Bhakharuan More, Daudnagar, Tehsil/Taluka-Daudnagar, Town/City- Daudnagar, Dist:- Aurangabad; Bihar-824113 for conducting B.Ed. programme of two years duration with an another intake of 50 (one basic unti) i.e. (existing 150 Intake + another 50 intake), thus making the total intake of 200 (two hundred) from the academic session 2017-2018 under Clause 7(16) of NCTE (Recognillon Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-
  - 1.4 The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDRs shallings be done:

The institution shall comply with the various athernorms and standards prescribed

In the NCTE regulations, as amended from time to time.

III. The institution shall make admission only after it obtains attitution from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.

IV., The institution shall ensure that the required number of academic staff duty approved by affiliating body for conducting the course should always remain in

position.

- · Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, diffillating University / Body, the State Government etc., as applicable.
- The Institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- The institution shall maintain its website with hyperlink to the Council and the Eastern Regional Committee, covering, inter-alia, the details of the institution, its location, name of the programme applied for with intake; availability of physical infrastructure, such as land, building, office, classrooms and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and nonteaching staff with photographs, for information of all concerned. e) Fee charged from students;

f) Available infrastructural facilities;

g) Facilities added during the last quarter,

h) Number of books in the library, journals subscribed to, and additions, it any, in the last quarter:
